## CVFMA Asks Members About Usage

**A**s a result of the July CVFMA Board of Directors meeting, a Repeater Steering Committee (RSC) was formed to assess the repeater wants and needs of the CVFMA membership. The RSC developed a questionnaire for the membership; the questionnaire attempted to determine the members' wants and needs for repeaters within the Association. In particular, the questionnaire attempted to determine if the CVFMA membership was content with the current repeaters, their locations and features. Focus was on repeater location; reception; features; use of tones; linking with other CVFMA repeaters; and I-89 usage. Of the 155 CVFMA membership, 46% completed the survey and sent their responses back to the RSC. A report has been prepared for the CVFMA President and the outcome of the survey will be published in the next newsletter.

The RSC appreciates deeply the time and effort taken by all CVFMA respondents; the strong showing indicates that the membership is using the 146.76 (Mt. Ascutney) and 147.24 (Moose Mtn.) repeaters and that the membership would like certain aspects of the CVFMA repeater configuration to change and other aspects to remain status quo.

Results will be announced imminently.

**CVFMA TEST SESSION de WB1GXM (contact: 603.543.1389)**

**T**he Association will be sponsoring a test session on Saturday, January 25, in the Sugar River Savings Bank Community Room (on Main Street, Newport, NH). Doors open at 8 a.m. and close at 8:45 a.m. when testing for all levels starts. Please remember to bring the following items with you:

- original FCC-issued license (if already licensed)
- Copy of original license (if already licensed)
- Original CSCEs you are claiming
- Copies of original CSCEs you are claiming
- one photo ID, or two non-photo IDs (one with an address)
- at least one pen, two pencils and a non-programmable calculator
- \$6.05 for the 1996 license fee for all test above Novice

The 5 wpm Novice (element 1A) Morse Code and theory tests (element 2) are free. The present test fee is \$6.05 covering all tests from Technician through Extra. To re-take a particular exam will cost an additional \$6.05.

Re-takes are encouraged but will be allowed based on time of day and availability of test materials.

There is no preregistration.

All applicants are expected to have materials that they need and have all paperwork organized; this will help all concerned.

If you are licensed and you upgrade, you may begin using your new privileges immediately. If you are not licensed, it will take about two weeks for your license to arrive in the mail. If you inquire on the FCC license information line, you will probably find it busy. PLEASE WAIT AT LEAST TEN (10) DAYS AND THEN CALL THE ARRL AT: 860.594.0300 (a toll call).

Another way: check in the World Wide Web at: <http://www.uair.edu/doc/hamuar1/callsign.him/>

This is how the ARRL does it. Calling after only 2-3 days only delays the needed information from being disseminated quickly.

## CVFMA Repeaters Have a New Club Callsign and a New Trustee

**B**y now, most CVFMA members have heard the new repeater ID on the 146.76 and 147.24 repeaters. In December, the CVFMA adopted the callsign of a CVFMA silent key: W1UWS.

In addition, after years of service to the CVFMA (and the loan of his callsign) Rudy Adler, W1GUA, has stepped down as trustee of the Association. Rudy's contributions have been significant and the Association thanks him for his time and support.

James Dean, N0JSR, has volunteered to serve as trustee of the Association and Form 610 has been submitted to the FCC for recognition of this change.

Reprogramming the Mt. Ascutney repeater, 147.76, was a straightforward task that was done over the telephone line. To reprogram the Moose Mtn. repeater, Leroy Bourn, N1TBB, visited the repeater site and replaced an EPROM chip. With those tasks done, the repeaters identify themselves as W1UWS.

Finally, Carl Snyder, N1JRA, is heading up the repeater maintenance committee. We can be assured of system operation and hardware configuration control.

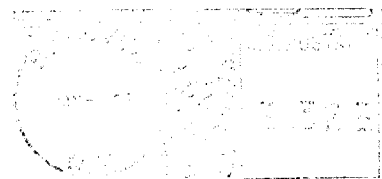
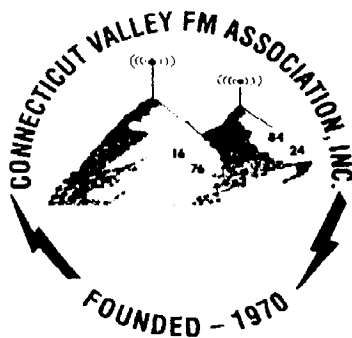

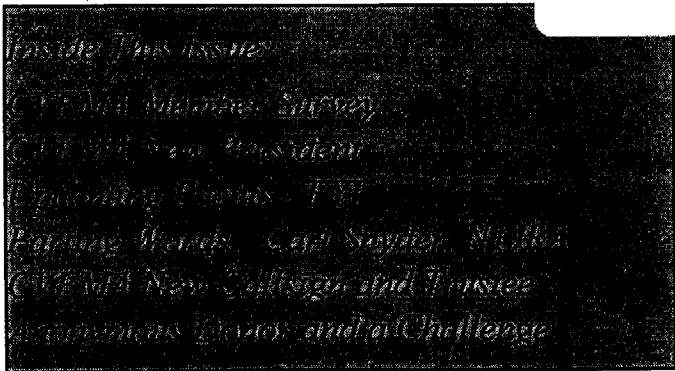
